# **Recommendations Out of Compliance**

The Commission finds that the following Recommendations are areas where Shoreline Community College is out of compliance with the NWCCU Standards for Accreditation. According to U.S. Department of Education Regulation 34 CFR 602.20 and Commission Policy, the Commission requires that Shoreline Community College take appropriate action to ensure these Recommendations are addressed and resolved within the prescribed two-year period.

The Commission recommends that Shoreline Community College:

- Recommendation 1: Fall 2020 Mission Fulfillment and Sustainability Provide evidence of a systematic method for collecting, storing, accessing, using and sharing data for the purposes of on-going and systematic evaluation, planning, resource allocation and informing decision-making toward improving institutional effectiveness and achieving mission fulfillment. (2020 Standard(s) 1.B.1;1.B.2)
- Recommendation 1: Fall 2022 Ad Hoc Report with Visit Engage in a systematic assessment process for all college programs, including transfer degree programs, through the use of programmatic and institutional outcomes to gather data that will be used for academic and learning support program planning and resource allocation (2020 Standard(s) 1.C.5;1.C.6;1.C.7)
