*Scholarships are for SCC tuition and fees related to tuition, and/or books and required materials available through the SCC Bookstore; and have no cash exchange value and are non-transferable.  
The award must be completed by spring 2013.*

### Criteria for Eligibility

- ❖ Applicant must be a Washington state resident (as defined by the college).
- ❖ Applicant must have a minimum cumulative GPA of 3.0.
- ❖ Applicant must display good academic performance and involvement in school and/or community activities.
- ❖ Applicant must be pursuing a degree in math, manufacturing or engineering.
- ❖ Applicant must plan to be enrolled at SCC with a minimum of 12 credits per quarter during the 2012 – 2013 school year.

To be considered, each applicant must submit 4 copies of the following in collated packets: (Please type)

1. Completed application. (OK to be handwritten)
2. Transcripts through winter 2012 (Unofficial are OK).
3. One page essay stating your qualifications, including:  
Career interests, personal background, educational goals.
4. Names of three references and their phone numbers and/or email addresses and their relationship to you (do not include family members).

Recipient will be required to attend the SCC Foundation award presentation.
