Hugh S. Cannon Foundation Scholarship

The Shoreline Community College Foundation will offer up to six individual scholarships of \$2,000 per award to SCC students who meet the eligibility criteria and who will be continuing their education at Shoreline during the 2012 - 2013 year. These scholarships are available for students who demonstrate good academic performance and have financial need.

Scholarships are for SCC tuition and fees related to tuition, books and required materials at SCC; and have no cash exchange value and are non-transferable. The award expires June 2013.

Criteria for Eligibility

- ❖ Applicant must be a U.S. citizen or legal U.S. resident or permanent U.S. resident with an I-551 Card.
- ❖ Applicant must have a minimum SCC cumulative GPA of 3.2.
- ❖ Applicant must show financial need, but not scheduled to receive Federal and/or State Financial Aid grants during 2012-2013.
- ❖ Applicant must have completed at least 20 credits at Shoreline Community College.
- ❖ Applicant must be currently enrolled at SCC with a minimum of 9 credits.

Application Procedures

To be considered, each applicant must submit **7** copies of the following in collated packets: (Please type)

1. Completed application (OK to be handwritten)
2. Shoreline Community College unofficial transcripts through winter 2012.
3. One page personal essay which includes:
Your career interests, personal background, educational goals.
4. One page personal essay stating what it would mean to receive this scholarship.
5. Completed Budget Worksheet (attached – OK to be handwritten)
6. Copy of Permanent U.S. Resident (I-551) Card (if applicable).
7. Names of three non-related references, their relationship to you and contact information

Recipient will be required:

1. To maintain a minimum 3.0 GPA each quarter in order to maintain their scholarship.
2. Attend the SCC Foundation Award Presentation.
