Student Insurance Updates

International students at Shoreline Community College are **REQUIRED** to have medical insurance during their studies. They may purchase insurance in their home countries before departure or purchase insurance through the College.

Who is eligible?

- Full time International Student enrolled in a minimum of 12 credits with a current passport and a valid visa status (F-1, J-1, or M-1).
- On Reduced Course Load (except if on second RCL for Medical Condition). Please submit completed RCL Request Form.
- Family member may enroll:

If an eligible student enrolls for coverage, they may also enroll their eligible dependents in the same plan at the same time the student enrolls. DEPENDENTS MUST BE ENROLLED; the date the student is enrolled on or within 31 days of birth, marriage, or upon arrival in the U.S. in order to qualify for

Who is not eligible?

- On second Reduced Course Load quarter for Medical Condition.
- On Optional Practical Training (OPT) (Please visit <u>www.temporaryinsurance.com</u> for insurance for OPT students).
- Applied for permanent residency in the U.S. in accordance with federal law in effect at the time of enrollment.
- Permanent Residents or US Citizens.

How much is the cost?

The cost of the Firebird International Insurance plan is US\$288.35 per quarter and it provides the following coverage. Coverage is also available for child(ren) and spouse during your studies:

- Maximum benefit of U.S. \$250,000 per illness or injury.
- Coverage anywhere in the world including your home country only in the event of an emergency.
- Medical evacuation back to your home country Minimum benefit of up to \$50,000.
- Repatriation of remains Maximum benefit of up to \$50,000.

Shoreline does not require **TOEFL** or **IELTS** for admission purposes.

If you have taken one of the following English assessment tests in the last 2 years and received a high score (see below), you may be eligible to enroll directly into college-level English or get placed at a higher ESL level.
