•SCC will provide Board Monitoring Reports related to the Core Theme objectives that do not meet an overall acceptable threshold of 75% of indicators for each objective. A Board Monitoring Report Schedule (timeline) will be presented to the Board for approval at the September 2012 Regular Meeting of the Board of Trustees.

### **Core Theme 2: Program Excellence**

•SCC will provide Board Monitoring Reports related to the Core Theme objectives that do not meet an overall acceptable threshold of 75% of indicators for each objective. A Board Monitoring Report Schedule (timeline) will be presented to the Board for approval at the September 2012 Regular Meeting of the Board of Trustees.

A Board Monitoring Report Schedule (timeline) will be presented to the Board for approval at the September 2012 Regular Meeting of the Board of Trustees.

•SCC will provide the Board of Trustees with at least semi-annual status reports on the Virtual College and Campus Internationalization initiatives.

•SCC will provide Board Monitoring Reports related to the Core Theme objectives that do not meet an overall acceptable threshold of 75% of indicators for each objective.
