Subject: Change of Summer Quarter 2023 start date from June 26, 2023 to

July 3, 2023 on 2022-2023 College Calendar

Background

The Board of Trustees approved the 2022-2023 academic calendar ("college calendar") at its meeting of April 21, 2022—with June 26, 2023 listed as the first day of instruction ("start date") for the summer 2023 quarter.

It was recently discovered that the ctcLink system will not calculate summer 2023 quarter financial aid awards correctly as the June 26, 2023 summer quarter 2023 start date is entered into the ctcLink system as falling within the prior academic year.

Therefore, this necessitates a change to the summer 2023 quarter's start date on the 2022-2023 College Calendar from June 26, 2023, to July 3, 2023.

Per <u>Policy 6000 (College Calendar)</u> and the <u>Policy 6000 (College Calendar) Procedure</u>, the aforementioned change requires Board approval.
