Purpose of the proposal and its anticipated effects, including any changes in existing rules: The College is proposing the repeal of Chapter 132G-136 and the creation of Chapter 132G-137 to provide updated and clarifying language regarding the Use of Facilities at Shoreline Community College. The updated code incorporates new model language that implements best practices for the smooth operation of Shoreline Community College’s buildings and grounds in support of our primary mission as an educational facility.

**Reasons supporting proposal:** Current language reflected in Chapter 132G-136 WAC Use of Facilities does not effectively clarify the rules for appropriate use for Shoreline's buildings and grounds. The updated language found in Chapter 132G-137 specifically identifies and provides direction for a variety of potential requests related to the use of college facilities.
