Senior Citizen Space Available Tuition Waiver

Program Regulations

- 1. Space is considered to be available on the FIRST DAY of the term, enrollment in the class is less than the capacity requirement. Based upon the instructor's discretion, approval for enrollment is not limited to available seats. Instructors may choose to overfill their course with a student using this waiver.
- 2. Registration prior to the FIRST DAY of the course will disqualify the student from using the waiver for that class.
- 3. If space is available (as defined by item 2), have the instructor sign the front of this form. Take the completed form with a registration form to the Enrollment Services Office.
- 4. Senior Citizens using this tuition waiver must register by the end of the second instructional week of the quarter. No registration will be permitted after that time.
- 5. Under this program, a student pays a \$5.00 non-refundable fee per quarter plus any applicable per credit fees. For example, any special fees specific to individual courses, such as computer lab fees.
- 6. The first quarter a student takes a course for credit at Shoreline Community College, he or she is required to complete an admissions application.
- 7. Under this program, Senior Citizens are eligible to register for up to two (2) courses.
- 8. Only state supported courses are available under this program.
- 9. Registration using this waiver is not permitted until after the FIRST DAY of the term. Tuition is due within 24 hours of registration.
