

**Articulation Agreement
Between
Goddard College and Shoreline Community College
(November 2012)**

Purpose

The objectives of this Articulation Agreement are to:

- (a) promote the transfer of graduates of Shoreline Community College's:

Associate in Arts Direct Transfer Agreement (AA – DTA)
Associate in Fine Arts (AFA)
Associate in Music (AM)
Associate in Science Transfer (AS – T)

programs into the Goddard College Undergraduate Program inclusive of the Individualized Bachelor of Arts, Bachelor of Arts in Sustainability, Bachelor of Arts in Health Arts and Sciences, and Bachelor of Arts in Education degree tracks and,

- (b) promote the transfer of graduates of Shoreline Community College's Associate in Arts Direct Transfer Agreement (AA – DTA) - English / Creative Writing into the Goddard College Bachelor of Fine Arts in Creative Writing Program.

Admissions Requirements and Transfer Status

Under the terms of this Articulation Agreement:

1. Goddard College will offer admission to Shoreline Community College AA – DTA, AFA, AM, and AS – T graduates retroactive to September 1, 2011 into the Goddard College degree tracks identified in the above items A – B.
2. Goddard College will provide up to 75 semester hours of transfer credits for students admitted into its programs for courses completed with a grade of C or better and who have completed the degree requirements associated with their Shoreline Community College program as outlined in Appendices C - K.
3. Goddard College will provide a \$1000 Community College Partnership Grant (distributed in \$500 awards for the spring '13 and fall '13 semesters) to Shoreline Community College graduates who enroll for the spring 2013 semester. Extension of this grant will be determined on an annual basis by Goddard College who will communicate the availability of the award to with identified Shoreline Community College staff.
4. Shoreline Community College graduates will submit the following application materials to the Goddard College Admissions Office for review:
 - Completed application form
 - Official Shoreline Community College transcripts (also official transcripts from previously attended schools, if applicable)
 - Application Essays as outlined on the application form
 - Personal interview with a member of the Goddard College Admissions Committee.

5. Shoreline Community College graduates who enroll at Goddard College having earned the Associate in Arts Direct Transfer Agreement, Associate in Fine Arts, Associate in Music or Associate in Science Transfer degree will be recognized as having met Goddard College's Undergraduate Wide-Knowledge degree requirement

Partnership Support


1. Shoreline Community College agrees to enable Goddard College staff and faculty to provide information sessions for prospective students on the Shoreline Community College campus with advance coordinated scheduling.
2. For the duration of the Agreement, Shoreline Community College will invite representatives of Goddard College to attend Shoreline Community College Transfer Fairs or other similar partnership/articulation promotion events.
3. For the duration of the Agreement, each institution will identify the partnership in the appropriate location on their public website and the Shoreline Community College degree planning guides.

Partnership Administration

1. The following staff from each institution are identified as Agreement administrators and will serve as the primary point of contact for their institution as related to this agreement:

Mickey Cronin, Associate Dean of Undergraduate Studies
 - For Shoreline Community College: James Jansen, VP for Academic/Student Affairs
Gillian Lewis, Dean, Health & Sciences Division
2. This agreement shall take effect for students seeking admission to Goddard College for the spring 2013 semester.
3. Review of this agreement shall take place between Goddard College and Shoreline Community College every two years starting in November 1, 2015.
4. Goddard College and Shoreline Community College will inform one another of changes in course or degree requirements in conjunction with the biannual review and revise the articulation agreements as needed during this period.
5. Either party with one (1) year notice may terminate this agreement.
