ASSUMPTION OF RISK

I, the undersigned, acknowledge that I am voluntarily participating in an intercollegiate athletic competition sponsored by the Shoreline Community College Athletic Department. I have been informed of and am thoroughly aware of the risks of participating in this competition, including risks of physical injury, loss of property, loss of life, or other consequences that may arise as a result of the activity. **I understand that intercollegiate athletic competition is physically strenuous and inherently dangerous and may result in bone or muscle damage, concussions, heart attack, hypothermia, dehydration, permanent disability, paralysis, or even death.** I understand that these risks and hazards may be caused by my own actions or inaction, the actions or inactions of others, or the condition in which the competition takes place. I recognize that there are both foreseeable and unforeseeable risks of injury or death that may occur as a result of my participation in this competition that may not be specifically listed. I also understand that there are risks in travel to and from this competition, including motor vehicle accidents resulting in injury or even death.

I personally assume all risks involved in my participation in and travel to and from this competition. I understand that Shoreline Community College, its officers, employees, agents, or representatives are not the guardians or insurers of my safety. I further understand that it is my responsibility to know if I have any health condition that might limit my ability to participate without endangering my health.

RELEASE OF LIABILITY

In consideration for my participation in this competition, I hereby fully release, waive, and discharge Shoreline Community College and its officers, employees, agents, or representatives (Shoreline Community College) from any and all liability, demands, claims, costs, expenses, injuries, damages, or losses including those resulting from the negligent acts of Shoreline Community College that I may otherwise sustain as a result of my participation in or travel to or from this competition.

INDEMNIFICATION

In consideration for my participation in this competition, I also agree to indemnify and hold Shoreline Community College harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in or travel to and from this competition and to reimburse the Shoreline Community College for any such expenses incurred.

SEVERABILITY

I also expressly agree that the foregoing assumption of risk, release and indemnification agreement is intended to be as broad and inclusive as is permitted by the law of the State of Washington and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
