This scholarship in the amount of two \$1,500 awards is available to two Shoreline Community College Medical Laboratory Technology students who will be continuing their education at Shoreline Community College. The awarded scholarship can be at any time between Spring 2020 quarter and Spring 2021 quarter

Scholarship is for Shoreline Community College tuition and fees related to tuition, and/or books and required materials available through the Shoreline Community College Bookstore. This scholarship has no cash exchange value and is non-transferable. The award must be completed by graduation or completion of the MLT Program.

Criteria for Eligibility

- Must have a 2.5 Shoreline Community College GPA or above
- Must be admitted into Shoreline Community College MLT Program
- Must be currently enrolled at Shoreline Community College
- Must be in good standing with Shoreline Community College
- Application considered regardless of previous associate, bachelor or advanced degree(s)

To be considered, each applicant must submit the following. Please do not include this application page. Each packet includes the following:

1. Completed **Application**
2. Current **Class Schedule**
3. **SCC Unofficial Transcript**
4. **One page typed personal essay** stating your educational and career goals and special needs.
5. **Letter of recommendation** from an adult who knows you well and can describe your characteristics, performances, experiences, strengths, knowledge, and capabilities.

Determination of Award

Recipient will be selected based on GPA, quality of essay submitted, and professional integrity and motivation. Selection committee will consist of Health Occupations faculty and/or MLT Advisory committee members.
