- Proposal: Sunset Retail Management 30 credit Certificate of Completion, Retail Management 45 credit Certificate of Proficiency, Retail Management AAAS
- Rationale:
  - Very few completions
  - No resources to manage and update these programs
  - Better off discontinuing them and putting efforts where efforts are best put
  - Will retain retail courses Retail Buying and Retail Marketing
- Motion passed by committee.

### • Proposal: Remove BUS& 101 prerequisite from BUS 160 Systems Thinking

- Rationale:
  - Students don't need any previous experience around systems thinking, since it's a 100-level course.
  - o Getting rid of BUS& 101 prerequisite will increase enrollment and access.
- The committee discussed the proposal.

<u>Beth:</u> How long has the course been available? Why was BUS 101 originally included as a prerequisite?

<u>Jessica</u>: At least for the three years I've been here. Probably added as a prerequisite since BUS& 101 is added to a lot of BUS classes.

Dan: What is BUS 160 a prerequisite for?

<u>Jessica:</u> It's a single course in our degree program. Doesn't open up to a 200-level course.

<u>Dan:</u> In addition to eliminating the BUS& 101 prerequisite, what other steps are taken to increase enrollment?

<u>Shanon:</u> Working on updating our programs and figuring out what students and industries are looking for, and how we can support that.

- Our Business transfer degree is one of the most highly enrolled at Shoreline. Those students are harder to track and take less BUS classes since they are transferring. Trying to find ways to engage with them in other ways outside of classroom.
- o BUS recruiting event, outreach recruiters, and recruiters in high school.
- o Creating more pathways for students in Prof-Tech degrees. Articulation agreements.

<u>Jessica:</u> This is a good one-off class for students outside of BUS. People from Boeing or Clean Tech, etc. take it. Don't want to have a barrier for students who aren't in Business.

- Motion passed by committee.
- The committee discussed the Entrepreneurship program.
- Leo is working on updating learning outcomes for Entrepreneurship classes.
- Shanon hopes to send out a survey to the committee to help get guidance and feedback.
- Ryan Taylor and Tim Sprangers are both in entrepreneurship. Good opportunity to reach out.

- Winter enrollment is up by about 5%.
- Ghost students are still a problem. College is working on preventative steps (e.g. New Student Orientation).
