May 2022 & November 2022 Meeting Minutes Approved

Program Update

- Tiffany's intern is doing well. Getting hands-on experience. Great opportunity to explore law enforcement roles outside of being an officer
- Linda visited the Mukilteo Police Department this week and met with the intern and his supervisor. He is having a great experience, including observing an oral board.

Program Outcomes

- Linda explained revised outcomes and purpose of outcomes. Positive feedback on the revised outcomes – well worded and measurable
 - Outcomes help measure success of students committed to program vs. not
- Potential additions: Wellness piece (recognizing stress in oneself and one's coworkers and identifying ways to deal with them)
 - Touched upon in some courses

Guided Pathways

- Linda is working on getting Anura's courses included as electives for the CJ AAAS

College Updates

Regional Academy CJTC

- Many hurdles in having SCC act as a regional academy – very little progress in this area
- Not enough human resources, qualifications, etc. to sacrifice to these regional academies
- Timeline for officers to get into the Academy is severely backed up (1+ year wait)
- Ideal to have systems in place that support this process. For instance, SCC could allow officers to earn credit after being hired
- SCC has had a program in place for approximately 8 years to give students credit for BLEA training after they present their state peace officer certificate to SCC. (20 credits available for DTA and 30 for AAAS). Numerous students have benefitted from this over the last few years.

Victims Services Certificate (Records/PDR)

- Hiring for record clerks and similar positions is taking months due to lack of qualified applicants
 - Certificates for record-keeping and similar skills would be a great opportunity for college to gain enrollment, and increase applicants with skills
 - College support and marketing help needed
- Also, there's opportunity to collaborate with other departments. (Hold mock scenario classes with Duygu in Drama, etc.) Utilize the overlap with other depts. to increase visibility and advocacy for the Criminal Justice program and law enforcement internships/positions
