1. Shoreline Community College:
  - a. State of the Class:

    - ii. Taught this quarter: Fundamentals, electrical, and A/C
    - iii. Did an untimed final this quarter. They students did very well
    - iv. Most are placed in dealers
  - b. Gary Fantozzi is the Automotive director
    - i. Guy and his boss talked about how automotive needed more administrative help
  - c. Clarke Hanson is the new Navigator
  - d. Recruitment:
    - i. Rob just presented at Oak Harbor High, and the teacher wants Rob to come back 3 times a year.
    - ii. SCC was just at the Auto dealership
    - iii. Gary was talking about him and Clarke going to High school career fairs
    - iv. Joe Long wants to help where he can
    - v. The breaking point is about 12 students, Robb would rather start with more and have more, than have less graduating.
