Outcomes mapping and General Education outcomes

- Projects at SCC over summer worked with outcomes mapping with departments. Looked at CJ 2-year degree, goals and Objective. Picked one and looked at how we are meeting these outcomes.
- Program outcomes as well as class outcomes were examined in CJ 101 (Forst and Caldwell both worked on this in different approaches during the summer), this class is well on its way to completing the program. Long range program, will take one or two courses to see that we are meeting our outcomes
 - The whole College is looking at general learning Outcomes. Quantitative is not addressed in CJ, but communication is.
 - \circ $\,$ CJ is leading the way in addressing these outcomes.
 - Critical thinking, self-management ie emotional intelligence, communication and career planning are all being addressed.

3:30 – 3:55 College Updates & What do you need from us?..... Rucks/All

- FTE, set-up for access to online ability
- Fill rate 84%, class are full
- CJ has 36 students a year, plus 20 graduates per year
- 60% are transfer students, and 1/3 are on the AAS track, 90 Community College credits
- CJ students are younger, 18–22-year-olds
- Running Start is down (way down) 7%
- Eastern Washington, enrollment is down 17-30%, means a lot of jobs lost
- We worked to cut travel, goods, and services for the CJ program to save money, we are tuition driven
- We are 55% women now, men trending downward in enrollments, 40% are White, but growing in diversity
- Pell eligibility is available, 60% are first time college students
- Next week our interim President will start.
 - National search for a new President by June, will start in August-September 2022

	 On the horizon, any technology you can suggest for our students, or any early exposure to the workforce you can provide, would be helpful Some can understand not wanting to run a course with only 4-5 students, the College is a business with a budget. However, some courses could be considered a loss, if not run. Some students may need the courses to transfer Required classes need to happen More work needs to be done prior to the start of the quarter, with recruitment and awareness, so courses will not be cancelled due to low enrollment A quarterly meeting is held with the Administration to determine if we run the classes with only 7-8 students As a student, we don't want to wait until offered the next year
