#### **IV. Shoreline Nursing Program Updates**

- a. Pru (1<sup>st</sup> Q) - so grateful that Hearthstone is still accepting students - vaccinated faculty can come in a be "patients"**
- b. Anna Sterner (Curriculum Committee) - including Covid into curriculum - Molly is addressing mental health/**
- c. Betty (4<sup>th</sup> Q) - integrating Covid into curriculum including renal failure and kidneys related to Covid. Evaluation Committee - reviewing outcomes**
- d. Mary - Two new faculty - Destry and Robert for 2<sup>nd</sup> Quarter - the program has been approved to hire 3 more tenure track faculty to start in the fall - mary is very excited. Due to regulation from the nursing commission - tracking clinical hours for nursing students - not more than 50% of clinical hours can be**

**simulation. Challenge when things change at a moments notice at clinical sites.**

**Virtual simulation has been integrated into the program – with no space and no sim lab the virtual sims has been working well. Students are getting a lot of clinical reasoning being strongly developed.**

**(Comment: Lindsey – Seattle Children’s – very impressed with the sims – very good with reasoning not so much with motor skills)**

**Skills lab – 70% in person / 30% virtual. 1<sup>st</sup> quarter in person skills labs in an in person environment.**

**Health Promotion clinical – this was revised last year – with a focus on peds with many improvements**
